Masterclass Terms and Conditions

Purpose

These Terms and Conditions govern participation in educational masterclasses delivered by The Savage Self-Care Coach. By registering for or attending a masterclass, participants acknowledge that they have read, understood and agreed to these Terms and Conditions.

1. Nature of the Masterclass

The masterclass is an educational service designed to provide general information relating to nutrition, health, lifestyle and self-care.

Information presented is educational in nature and is not intended to replace personalised medical, nutrition or allied health advice.

Participation in the masterclass does not establish a practitioner–client relationship or constitute an individual clinical nutrition consultation.

2. Eligibility

Questions submitted during the masterclass will be answered in a general educational manner only.

4. Health Responsibility

Participants remain responsible for their own health decisions.

The Savage Self-Care Coach recommends consulting an appropriately qualified healthcare practitioner before implementing significant dietary, lifestyle or supplement changes.

If you experience a medical emergency, seek immediate medical attention.

5. Registration and Payment

Full payment is required before access to the masterclass is provided.

Registration is personal and may not be transferred, shared or resold without written permission.

Pricing is displayed at the time of registration.

6. Cancellations and Refunds

Refunds are provided in accordance with the Savage Self-Care Coach Cancellation and Refund Policy.

If a participant cancels before the advertised commencement time of the masterclass, a refund may be provided in accordance with the published Refund Policy.

Once the masterclass has commenced, or recordings or educational materials have been accessed, refunds will not be provided except where required under Australian Consumer Law.

If The Savage Self-Care Coach cancels or substantially reschedules the event, participants will be offered an alternative session or a full refund.

7. Attendance

Participants are responsible for ensuring they have:

- a suitable internet connection;
- a compatible device;
- access to the meeting platform prior to commencement.

Technical issues occurring on the participant's end do not automatically entitle the participant to a refund.

The masterclass may be recorded.

By participating, attendees acknowledge they may appear in the recording if they choose to:

- enable their camera;
- unmute and speak;
- participate verbally.

Participants may choose to keep their camera and microphone switched off.

Where practical, recordings distributed after the event will focus primarily on the presenter.

9. Participant Conduct

- behave respectfully toward other attendees;
- avoid disruptive behaviour;
- avoid abusive, discriminatory or inappropriate comments;
- refrain from promoting products or services during the event.

The Savage Self-Care Coach reserves the right to remove participants whose behaviour disrupts the learning environment without refund.
